Receipts Receipts are stated as received and net of Bank / 'Just Giving' transaction fees

Child Sponsorship Is donations preferred to be used for student sponsorship

Fund Raising & Donations Is general donations and sponsored events.

Bank Interest Is interest received on bank credit balances

Loans Received Is monies loaned by Trustees for hosting fees charged to Trustees credit cards.

Bank Compensation Is compensation received for bank errors

Payments Foreign payments are converted to British Pounds at the average exchange rates for the year

Child Sponsorship Is the sponsorship for pupils to attend high school

Fund Raising Is the entry fees for fund raising events + web site hosting fees

Loans Repayment Is repayment of the monies loaned by Trustees to cover late receipt of joint fundraising monies and hosting fees

Bank Transfer Fees Is the bank fees charged for transfering monies overseas

Just Giving Monthly Fees Is the monthly fee for the 'Just Giving' donation service

Bank Error Is a direct debit error refunded the following financial year
